### Market Snapshot:

After the status quo decision by the MPC committee, a knee-jerk reaction was observed across the board, but indices soon started to recover from their lower levels as private banking counters took charge. Later, collective efforts by different sectors propelled the Index to soar higher, closing the trade at 24,836.30 with gains of 225.20 points. The Media sector was the top gainer, followed by Defence and BankNifty, while the PSU Banking segment was the only laggard in today's trade. Mid and small caps also rallied by 0.89% and 1.10%, respectively.

◆ **LTTS wins USD100mn multi-year deal with US industrial equipment manufacturer:**

The company announced a major milestone in its Sustainability segment with the signing of a USD100mn multi-year agreement with a US-based industrial equipment manufacturer catering to the semiconductor value chain.

◆ **RITEES signs MoU with Etihad Rail to expand mobility sector collaboration in UAE:**

The company has signed a MoU with Etihad Rail and its subsidiary, National Infrastructure Construction Company (NICC) LLC, to enhance business collaboration in the mobility sector across the UAE and beyond.

◆ **BHEL wins orders worth up to Rs150bn from MP power generating company:**

The company received a large order from the Madhya Pradesh power generating company for two projects. The order, valued between Rs130bn to Rs150bn, pertains to EPC packages of 1x660MW Amarkantak Unit No. 6 and 1x660MW Satpura Unit No. 12 Supercritical Thermal Power Plants in Madhya Pradesh.

◆ **Nestle inks MoU with food processing Ministry to expedite investments:**

The company has signed a MoU with the Ministry of food processing Industries to expedite the investments in greenfield and brownfield projects, in Odisha and its existing manufacturing locations.

◆ **Lupin gains US FDA approval for pediatric use of Rivaroxaban oral suspension:**

The company announced that it has received approval from the USFDA for its ANDA for Rivaroxaban for Oral Suspension, 1 mg/mL. The product is bioequivalent to Xarelto for oral suspension, 1 mg/mL of Janssen Pharmaceuticals, Inc.. According to IQVIA MAT July 2025 data, Rivaroxaban for Oral Suspension, 1 mg/mL (RLD Xarelto) had estimated annual sales of USD11mn in the US.
