HCLTech to acquire Hewlett Packard Enterprise's telco solutions business for USD160mn:

The company has signed an agreement to acquire the telco solutions business of Hewlett Packard Enterprise (HPE) to strengthen its engineering and AI-led network propositions for global communication service providers (CSPs). The total purchase price is up to USD160mn, including USD15mn of incentives linked to FY25 performance.

Lupin signs exclusive licensing pact with Neopharmed for Plasil in Philippines and Brazil:

The company's subsidiaries in the Philippines and Brazil have entered into an exclusive licensing agreement with Italy-based Neopharmed Gentili S.p.A for marketing and promotional rights of the gastroenterology brand Plasil in their respective markets. Under the agreement, Lupin's Philippines subsidiary, Multicare Pharmaceuticals, and its Brazil subsidiary, MedQuimica, will market and promote Plasil, which contains metoclopramide.

JSW Energy to double Salboni thermal power capacity with Rs400bn investment:

The company plans to expand its Salboni thermal power project in West Bengal to 3,200MW, raising total investment to around Rs400bn, as part of its strategy to strengthen thermal capacity and meet rising power demand in the state.

Capgemini-WNS deal signals shift toward AI-led business transformation:

The company has announced a definitive agreement to acquire WNS, a top digital-led business transformation and services company, for USD76.50 per share in cash. The total consideration is approximately USD3.3bn, excluding WNS's net financial debt. This strategic move positions Capgemini as a dominant player in the rapidly evolving Digital Business Process Services (BPS) and Intelligent Operations markets.

GPT Infra bags Rs18.04bn flyover contract from MCGM:

The company has secured a contract valued at Rs18.04bn from the Municipal Corporation of Greater Mumbai (MCGM). The project involves the construction of a flyover along LBS Marg, connecting Kalpana Talkies Kurla (L Ward) to Pankhe Shah Dargah Ghatkopar West (N Ward) in the Eastern Suburbs. The contract will be executed over 36 months, excluding monsoon periods. The project is structured as a joint venture, with GPT Infraprojects holding a 26% share, equivalent to Rs4691.6mn.
