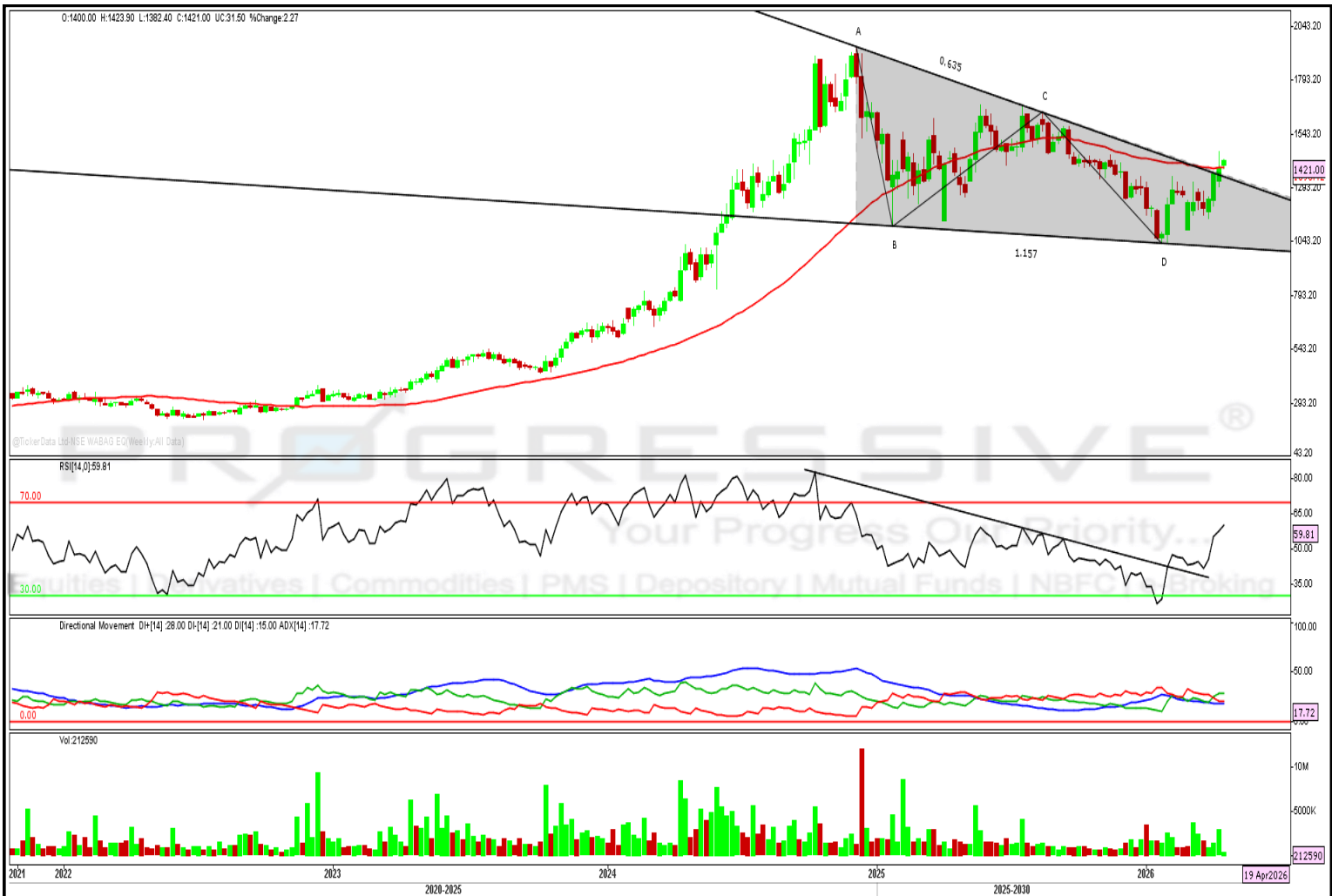

- Oscillator **RSI** has already given a long term trendline breakout and recently, it surpassed its previous swing high
- **+DMI** has crossed **-DMI** which is a positive sign and a reading of 18, suggests the beginning of a new trend
- Trend following indicator **MACD** has given a **Positive Crossover**

Recommendation:

We recommend a **BUY** on the company at current market price of Rs1421 with decline upto Rs1384 with a closing stop loss of Rs1100 for a target of Rs1807-Rs2193 with a horizon of 9-12 months.
