Tata Motors explores raising funds for EV business:

Tata Motors is evaluating opportunities to raise capital from potential strategic partners or investors, including private equity funds and sovereign wealth funds, for its Electric Vehicle (EV) business as the automaker works towards building a range of affordable electric cars. In March 2020, the Tata Motors board had approved a plan to hive off the passenger vehicle (PV) business, which includes EVs, into a separate subsidiary and seek investors to help the unit secure its long-term viability.

Hero MotoCorp hikes bike, scooter prices by up to Rs3,000 from July 1:

Hero MotoCorp will hike the prices of its motorcycles and scooters by up to Rs3,000 from July 1, 2021. The prices have been increased due to rising commodity prices. The price hike has been necessitated to partially offset the impact of continuous increase in commodity prices. The company continues to drive cost savings programs aggressively, in order to minimise the impact on the customer. The price hike across the range of motorcycles and scooters will be up to Rs 3,000 and the exact quantum of the increase will depend on the basis of the model and the specific market.

SEBI exempts Heineken International from open offer obligation in UBL case:

Markets regulator SEBI exempted Heineken International B V from the obligation of making an open offer following its proposed acquisition of shares in United Breweries Ltd. As per the application, the acquirer or Heineken International is presently evaluating the acquisition of a maximum of 3,96,44,346 equity shares, amounting to 14.99%, of UBL (target company) from the recovery officer, who is holding and is in the custody of such shares.

ISGEC Heavy Engineering Ltd bags order for 100th unit of CFBC Boiler:

ISGEC has announced that the company has crossed the impressive milestone of 100 CFBC Boilers. These Boilers cut across a wide spectrum of industries and sectors. The CFBC technology offered is state-of-the-art and regarded as the latest generation technology that offers customers benefits in terms of Low Maintenance, Higher Availability, Higher Efficiency, Low LOI in Ash, and a wide range of fuel firing capabilities. The technology is proven to efficiently burn a wide variety of solid fuels such as low ash imported coals, high sulphur petroleum coke, high ash Indian coals, dolochar, washery rejects, high moisture lignite, and biomass. This technology also proves to be ideal for controlling emissions.

Pfizer in final stages to get nod for Covid vaccine in India: CEO Albert Bourla:

Pfizer is now in final stages to get approval for its Covid-19 vaccine in India. The vaccine was developed by Pfizer in partnership with the German firm BioNtech. It has a very high efficacy of over 90% in preventing the infection. Pfizer, which is ready to offer 5 crore doses to India between July and October this year and has sought certain relaxations including indemnification, has held a series of interactions with the Indian government authorities recently including one this week.

Cipla receives final approval for generic version of Sunovion Pharmaceuticals, Inc.'s Brovana:

Cipla has received final approval for its ANDA for Arformoterol Tartrate Inhalation Solution 15 mcg/2mL from the USFDA. Cipla's Arformoterol Tartrate Inhalation Solution is AN-rated generic therapeutic equivalent version of Sunovion Pharmaceuticals Inc.'s Brovana. According to IQVIA (IMS Health), Brovana had US sales of approximately USD438mn for the 12-month period ending April 2021.
