- RSI oscillator managed to surpass its 3 years stiff resistance of 53 (Horizontal Line).
- +DMI stands well above -DMI and ADX. With a reading of 21 in ADX, suggesting starting of a new trend which is an uptrend.
- 12 MMA (Monthly Moving Average) is acting as strong support (Red Line).
- From the past couple of months, an uptick in volume indicates good accumulation from lower levels.

Recommendation: We recommend a BUY at current market price of Rs139 or decline upto Rs134 with a closing stop loss of Rs96 for a target of Rs186-Rs233 with a horizon of 9-12months.
