- Surge in Volume from the past couple of weeks indicates strong market participation

# **Recommendation:**

We recommend a BUY on the company at current market price of Rs53 or decline up to Rs51 with the closing stop loss of Rs30 for a target of Rs79-Rs105 with a horizon of 9–12months.
