#### **Investment Rationale:**

- Jay Bharat Maruti Ltd has given a breakout from 2 year consolidation with a traditional reversal pattern Inverted Head & Shoulder Pattern.
- RSI oscillator has surpassed mid-way point which was acted as a resistance earlier.
- Price breakout was confirmed with Volume Breakout.

**Recommendation:** We recommend a BUY at current market price of Rs300 or decline upto Rs273 with a closing stop loss of Rs220 for a target of Rs383-Rs465 with a horizon of 9–12months.
