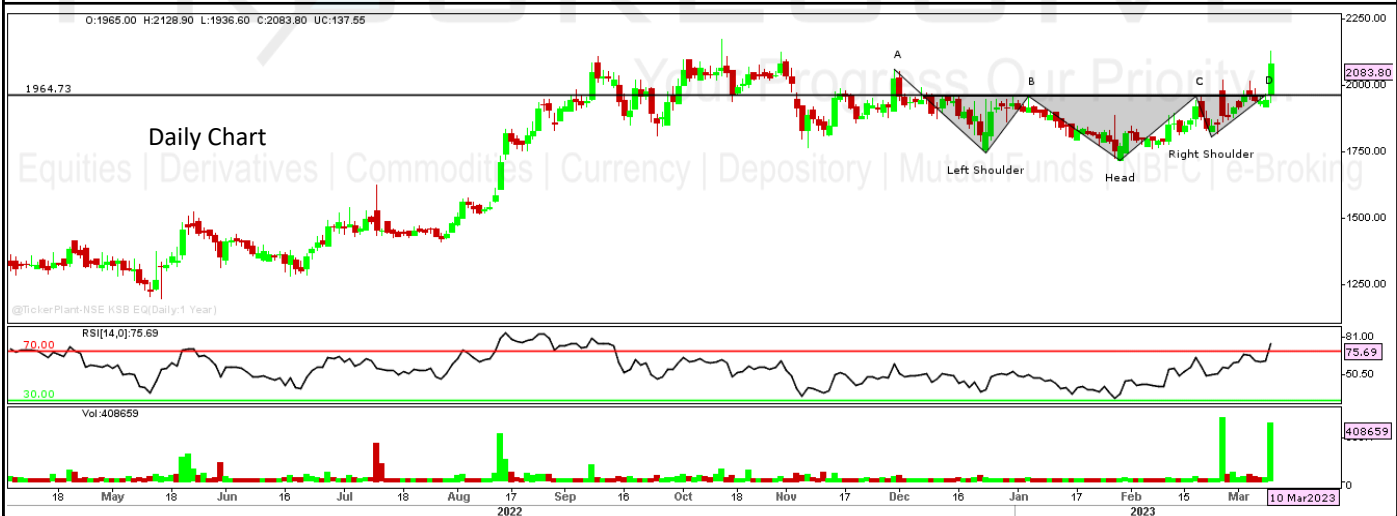
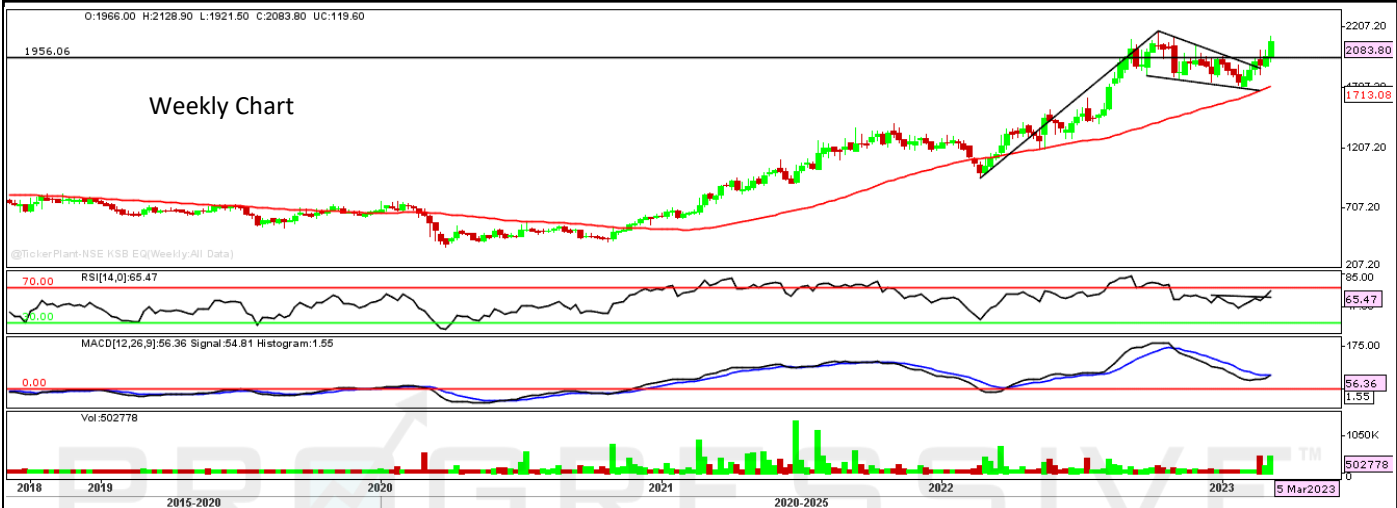

Investment Rationale:

- KSB Ltd has given a breakout from the continuation pattern **Flag & Pole formation (Upper Panel)** and from the **Inverted Head & Shoulder formation (Lower Panel)**
- **RSI oscillator** has also given a breakout from the Inverted Head & Shoulder pattern (**Upper Panel**)
- Trend following indicator **MACD** has given a positive crossover (**Upper Panel**)
- Uptick in the **Volume** confirms price behavior

Recommendation:

We recommend a **BUY** on the company at current market price of Rs2084 or decline up to Rs2000 with the closing stop loss of Rs1770 for a target of Rs2507-Rs2930 with a horizon of 9-12months.
