Investment Rationale:

- Indian Bank has given a breakout from an Ascending Triangle Pattern.
- Trend line breakout was observed in RSI.
- MACD indicator has given a positive crossover.
- Price breakout was confirmed with Volume Breakout.
- Joint breakout was witnessed where **PSU Banking sector** has also given a triangle breakout.

Recommendation:

We recommend a **BUY** on the company at current market price of Rs165 or decline up to Rs155 with the closing stop loss of Rs124 for a target of Rs194-Rs222 with a horizon of 3–6months.
